





## SHRINK WRAP FORM

**SHRINK WRAP:** Shrink wrap is a protective and effective form of winter cover. However, in storm conditions, shrink wrap and all types of framing can become damaged. Shrink wrap price does not include any repairs to shrink wrap due to storm damage during winter storage. If such damage occurs, THE MARINA will notify the owner and any repairs authorized will be billed at regular rates. THE MARINA will not be held responsible for damages that occur to shrink wrap or boats due to inclement weather or acts of God. Removal of equipment, fittings, enclosures and antennae are not included in the price.

NOTE: Like all cover systems there is often movement in shrink wrap that can result in scuffs or rubmarks. Blistering may be a side effect of shrink wrap when vessel is covered depending upon condition and maintenance of gelcoat and paint.

The marina assumes no responsibility for damage to canvas or isinglass during the removal or installation of material for shrink wrapping. It is recommended that all isinglass be removed and stored elsewhere for the winter to lower the possibility of damages occuring.
